1. Purpose

2. Duties of the Society / Club President

- 2.1. The President is the sole person responsible for the Society / Club and must be held by a single person, who is a member of Van Mildert College JCR.
- 2.2. They must ensure the Society / Club remains in good financial standing.
- 2.3. They must ensure all guidelines (e.g. best practice, health & safety, and constitutional) pertaining to the Society / Club are followed.
- 2.4 They must act as a point of contact for the Society / Club.
- 2.5 They must not bring the JCR into disrepute.
- 2.6 They must ensure the Society / Club operates fairly and acts in the best interest of its members.
- 2.7 They must ensure the Society / Club fulfils its aims and objectives.
- 2.8 The term of the Society / Club President starts on the first day of summer vacation and ends on the last day of Easter term the following year.

3. Finances

- 3.1. The Society / Club must produce a budget at the start of each academic year.
 - 3.1.1. This must be sent to the JCR FACSO three weeks before the start of Michaelmas term.
 - 3.1.2. This must include a projection of all expenditure and income related to the Society / Club for the subsequent academic year.
 - 3.1.3 The Society / Club President must ensure the Society / Club does not spend more than the budgeted spending.
 - 3.1.4 The Society / Club President may seek Finance Committee approval for further spending, for example in the case where subs income was greater than predicted.
- 3.2. The Society / Club must collect annual subs from its members to fund part of its expenditure.
 - 3.2.1. The JCR will match these subs in a 1:1 ratio up to the value listed in the

Society / Club budget for subs income.

- 4.2.2 Subs must be collected and paid in full into the JCR accounts in Michaelmas term, by a deadline set by the FACSO.
- 4.2.3 If subs are not received by this deadline, the Society / Club will be banned from spending until subs are received in full.

4. Governance & Elections

- 4.1 The Society / Club must hold an Annual General Meeting (AGM) every academic year.
 - 4.1.1. At least five weeks notice must be given for an AGM (this may be waived by Governance Committee under extreme circumstances).
 - 4.1.2. The AGM must take place during Easter term.
 - 4.1.3. At least one third of the Society / Club membership must be in attendance for the AGM to be quorate.
- 4.2 The Society / Club President must be elected at the AGM in a fair and transparent process.
 - 4.2.1. A record of this must be sent to Governance Committee at most two weeks after the AGM.
 - 4.2.2. A member of Governance Committee may observe this process.
- 4.3 The Society / Club may have a constitution supplementary to this governing document.
 - 4.3.1. This may set out additional rules and guidelines, such as other officials to support the President.
 - 4.3.2. This must not contradict this governing document.
 - 4.3.3. This must be approved by Governance Committee.
 - 4.3.4. A constitution may be a requirement for a Society / Club of a certain size or financial status.
- 4.4 Members of the Society / Club must be members of Van Mildert College JCR.

5. Conduct

- 5.1. All Society / Club members must act in a respectful and appropriate manner.
- 5.2. All Society / Club members must act in accordance with section 6.20. of Van Mildert College JCR Permanent Standing Orders.
- 5.3. Alleged misconduct by a member of the Society / Club must be investigated in a fair, transparent, and appropriate manner.
 - 5.3.1. In the first instance, alleged misconduct must be investigated by the Society / Club President; and the JCR President and JCR Chair must be informed.
 - 5.3.2. Where escalation is appropriate, the procedure outlined in section 10 of Van Mildert College JCR Permanent Standing Orders must be followed.
- 5.4. The Society / Club President must take reasonable measures to ensure the good conduct of the Society / Club and its members.
